1. **Bhojpur municipality office of the Municipal Executive, Bhojpur** invites sealed bids or electronic bids from eligible bidders for the construction and *upgrading of road mentioned below* under National Competitive Bidding procedures.

A complete set of Bidding Documents may be purchased from the office of **Bhojpur municipality, Bhojpur** and the District development committee office, Bhojpur by eligible Bidders on the submission of a written application, along with the copy of Notary certified, company/firm registration certificate, PAN/VAT certificate, Tax clearance certificate of fiscal year 2072/73 and upon payment of a non-refundable fee as mentioned in the table below till office hour of 2074/01/05. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost. However, the Employer will not be responsible for delay or non-delivery of the documents so sent. Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np](http://www.bolpatra.gov.np). Bidders, submitting their bid electronically, should deposit the cost(as mention below) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Sealed or electronic bids must be submitted to the office of **Bhojpur municipality, Bhojpur** by hand/courier or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). on or before 12:00 hrs of 31<sup>st</sup> Day of publication of Notice. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **[Time and date]** at the office of **Bhojpur municipality, Bhojpur**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **mention below**. which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Municipality office reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
